The Wall Township Board of Education received your Open Public Records Act (OPRA) request on September 12, 2016. Your OPRA request sought access to the following:

"...the bill from the vendor, PO and copy of front and back of check for the 3 payments out of Food Service.

1. Connected Office products. 11/5/2007 - \$36,650.80, Equipment
2. Net Q Multimedia Company 11/20/2007 - \$7,050.00, supplies
3. Connected Office products 11/20/2007 - \$6,034.22, supplies

May I also have a check register report for just these 2 vendors (Connected Office Products and Net Q Multimedia Company) paid out of any Wall BOE bank account beginning with 2003."

In response to item number two (2.), attached please find a copy of invoice 70439 and the front and back of check number 8191.

In response to item number three (3.), attached please find a copy of invoice number M89966 and the front of check number 8175.


In response to your request for check register reports, attached please find Food Services Check Register reports for Connected Office Products, Inc. and Net Q Multimedia Company from January 2003 to August 2016.

Please be advised that the district has performed a search of district records and has determined that no records exist for corresponding purchase orders or copies of the back of checks numbered 8192 and 8175.

These records are being transmitted to you via e-mail, as per your request. Pursuant to N.J.S.A. 47:1A-5.b., the cost associated with this request is \$0.00.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Wall Township Board of Education to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
