The Wall Township Board of Education received your Open Public Records Act (OPRA) request on April 18, 2017.

Your OPRA request sought access to the following:

"...all payments via a check register made to 11-000-270-443-014 (lease purchase), 11-270-517-014 (moesc reg ed esc), 11-000-291-210-001 (health benefits) for 12/13, 13/14, 14/15, 15/16 and to date 16/17" [sic]

In response to your request, attached please find the following:

- Check Register By Check Date for account number 11-000-270-443-014 (Lease Purchase) for school years 2012/2013, 2013/2014, 2014/2015, 2015/2016, and 2016/2017.

With regard to your request for a check register for account number 11-270-517-014 (moesc reg ed esc), please be advised that this is an invalid account number. However, in an attempt to respond to your request, the district is providing the following:

- Check Register By Check Date for account number 11-000-270-517-014 (MOESC Reg. Ed.) for school years 2012/2013, 2013/2014, 2014/2015, 2015/2016, and 2016/2017.


With regard to your request for a check register for account number 11-000-291-210-001 (health benefits), please be advised that the account number referenced is not for health benefits. However, in an attempt to respond to your request, the district is providing the following:

- Check Register By Check Date for account number 11-000-291-270-001 (Health Benefits) for school years 2012/2013, 2013/2014, 2014/2015, 2015/2016, and 2016/2017.

These records, totaling 53 pages, are being transmitted to you via e-mail, as per your request. Pursuant to N.J.S.A. 47:1A-5.b., the cost associated with this request is \$0.00.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Wall Township Board of Education to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ 08625, by e-mail at [grc@dca.state.nj.us](mailto:grc@dca.state.nj.us), or at their web site at [www.state.nj.us/grc](http://www.state.nj.us/grc). The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
