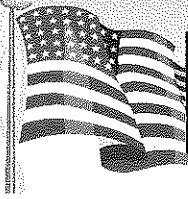

## **TWO ONE YEAR \$1000 SCHOLARSHIPS ARE AVAILABLE**

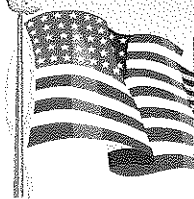
The Scholarship Committee has established the following criteria for eligibility for Two individual one year scholarships in the amount of \$1000 each:

1. Applicant must be a New Jersey resident.
2. Applicant must be a natural or adopted descendant of a member of Disabled American Veterans of New Jersey (son, daughter, grandson, granddaughter, etc.)
3. Must be a graduating High School Senior
4. Applicant must submit an essay of no more than 500 words on:

**“Old Glory”, The Flag of our Country and The symbol of Freedom**

5. Applications and essays must be typed or printed legibly and in its entirety.
6. Must provide proof of relationship and proof that veteran is a member of the Disabled American Veterans.
7. Must provide a letter of acceptance from a college of your choice.
8. Feel free to enclose letters of recommendation. Essays will be graded for spelling, punctuation and grammar. Be sure to mention your extra curricular activities and awards you may have received,
